#### **UPDATE OF CHOIR MAJOR MAGNITUDE FIELD TRIP TO SAN ANTONIO, TEXAS:**

Kathie Brekke, Moorhead High School choir director, provided an update on the January 14-17, 2016 major magnitude field trip to San Antonio, Texas. The students participated in a choral clinic at the University of Texas at San Antonio and a exchange concert in San Antonio. Kathie shared highlights of the trip and a short video of the choir's performance.

### MAJOR MAGNITUDE FIELD TRIP REQUEST - MOORHEAD HIGH SCHOOL BAND

**TRIP**: Missy Eidsness representing Pam Redlinger, Moorhead High School band teacher, provided information related to the proposed major magnitude field trip request for Moorhead High School band students to travel to Orlando, Florida, for six days and five nights. The trip will occur from March 22-27, 2017. The purpose of the trip is to provide band students the opportunity to perform in a festival setting, listen to and evaluate other bands that perform at the festival, and participate in You're Instrumental - A Disney Performing Arts Workshop. The trip to Orlando, Florida, gives band students an opportunity to meet many of the course standards for band within a four-day trip. The anticipated cost per person is \$1,550.

Steffes moved, seconded by Erickson, to approve the major magnitude field trip to Orlando, Florida, from March 22-27, 2017 for the band students. Motion carried 7-0.

**2016 SCHOOL FINANCE AWARD**: Brandon Lunak, assistant superintendent of finance and operations, provided information regarding Moorhead Area Public Schools (MAPS) earning the Minnesota Department of Education's (MDE) 2016 School Finance Award for fiscal year 2015. The award recognizes select school districts for timely submission of Uniform Financial Accounting and Reporting Standards (UFARS) data and annual financial statement as required by Minnesota Statutes as well as for having positive fund balances, demonstrating sound fiscal policies and procedures, and personnel training in the area of school finance. Lunak also thanked the district's business office staff for their efforts related to the award.

OVERVIEW OF K-12 HEALTH AND PHYSICAL EDUCATION: Missy Eidsness, assistant superintendent of learning and accountability, reported Moorhead Area Public Schools has researched and reviewed curriculum for health and physical education during the 2015-16 school year. Elementary, middle school and high school teachers reviewed standards and curriculum maps to identify resources needed to support instruction. Lindsay Weaver, S.G. Reinertsen Elementary physical education teacher, Brian Meyer and Cody Martinson, Horizon Middle School physical education teachers, and Greg Salvevold and Stacey Holm, Moorhead High School health and physical education teachers, presented overviews of the health and physical education curriculum taught in Moorhead Area Public Schools.

Altenburg moved, seconded by Valan, to approve the K-12 health and physical education curriculum. Motion carried 7-0.

Bid documents for bid group 1 for the Horizon grades 5-6 school will be available for bidding beginning March 15. Bid opening is April 7. Bidding also is open for the K-5 remodels with the bid opening set for March 22.

**MOORHEAD SCHOOLS LEGACY FUND UPDATE**: Lisa Borgen and Rob Bye, Moorhead Schools Legacy Fund committee members, provided an update on the progress made to establish a foundation.

At the September 8, 2012 School Board meeting, district administration was given direction to work toward establishing a foundation. The administration formed a steering committee to develop an advisory committee and structure for the foundation, which was named the Moorhead School Legacy Fund.

The Moorhead School Legacy Fund was developed as a way for the community to show pride in students and to help support and enhance the ever-changing needs of the school district's programs and facilities. The Legacy Fund would be governed by an advisory committee with the objective of soliciting ongoing charitable contributions to establish a strong financial base to ensure continued effectiveness of programs, events and facilities that benefit the education, growth and opportunities of students in Moorhead Area Public Schools. The Moorhead School Legacy Fund committee would be responsible to accumulate, manage, invest and distribute funds to Moorhead Area Public Schools.

The Legacy Fund Advisory Committee includes eight voting members: Jean Sando, teacher representative, Chuck Gulsvig, retired teacher and community member, and Tracy Briggs, Jerry Arneson, Rob Bye, Lisa Borgen, Abby Boggs-Johnson and Corey Elmer, all community members. Ex-officio members are Brandon Lunak, district administration, Matt Valan, School Board, and Pam Gibb, district communications coordinator. Officers are Jean Sando, chairperson, Chuck Gulsvig, vice chairperson, and treasurer TBD.

The Moorhead School Legacy Fund Advisory Committee began meeting in July 2015 and approved a name change to the Moorhead Schools Legacy Fund to ensure potential donors x understand that the focus is for all Moorhead Schools. The mission of the Moorhead Schools Legacy Fund is "Enhancing the educational experience of all students in Moorhead Area Public Schools ISD 152." The focus is to seek larger donor gifts from individuals and/or families for charitable giving as well as corporate grants and government grants. The committee approved and established five component fund areas: Endowment Fund, Activities and Event Fund,

The Moorhead Schools Legacy Fund Advisory Committee continues to research and discuss which organization will hold the Moorhead Schools Legacy endowment and/or component funds. The committee learned that North Dakota offers a tax incentive for charitable giving. Moorhead alumni and corporate entities that reside in North Dakota may want to make charitable to charitable organizations and reduce their income tax bills. The individual or corporate donors who make gifts to qualified endowments may qualify for a state income tax credit equal to 40% of the value of the gift, up to a maximum credit of \$10,000 per year for corporations or \$10,000 per individual or \$20,000 per year per couple. In order for a North Dakota individual or corporation to take advantage of this tax incentive the endowment fund must be held in a qualified North Dakota nonprofit organization, bank or trust company holding the fund on behalf of the nonprofit organization. The committee is currently reviewing the options for the holding of the endowments to take advantage and qualify for the North Dakota tax incentive.

Additionally committee members met with representatives from school district foundations in Fargo, N.D., and Alexandria, Minn. The committee is currently in strategic planning sessions with the Moorhead Area Education Foundation in reviewing the 501(c)(3) status, bylaws and procedures. The Moorhead Schools Legacy Fund Advisory Committee also is developing a fundraising and marketing strategy, a donor qualifying plan and a future top capital projects plan.

<u>SUPERINTENDENT REPORT</u>: Dr. Kovash reported she attended a tour with area education networks of the Career and Technical Education Academy and new Tech High in Sioux Falls, S.D. She noted it was a great opportunity to see different education programs. Kovash said she and Bryan Thygeson, D-G-F superintendent, would be presenting the boundary resolution to the Senate and House Committees on March 15 and 16.

<u>COMMITTEE REPORTS</u>: Brief reports were heard related to the District Health Insurance Committee, Joint Powers Committee, Moorhead Schools Legacy Fund Advisory Committee, and Community Facilities Task Force meetings, and the community open house about the native play space at Ellen Hopkins Elementary.
